Submit your roster and payment to the Gilruth Center Information Desk. 5. All attached checks and/or credit card numbers on confirmed rosters will be cashed or charged immediately for the full team fee unless otherwise noted and validated by signature. 6. The Starport Sports and Recreation department will EMAIL to confirm your team's spot in the league. All leagues are on a first come first served basis. 7. All rosters are considered final by the fourth week of play. 8. No refunds will be made on or after the start date. There is a \$25 processing fee for refunds requested 2 weeks prior to the league start date. 9.
